



REGULATIONS FOR THE ZINAL COMMUNAL SWIMMING POOL

1. All persons entering the pool are subject to the provisions of these rules and must comply strictly with the instructions and observations of the staff.
2. Order and decency must prevail in and around the establishment. Any behaviour or act contrary to public morality or likely to be detrimental to good order, the safety of the public and users, as well as any acts likely to damage or soil the facilities and buildings are prohibited and liable to be reported.
3. Any fraudulent entry into the bathing establishment will be the subject of a written report by the staff in charge and may give rise to a penalty, in accordance with section 4, as well as the payment of a fine of CHF 200.
4. Violators of these regulations may be subject to expulsion. Depending on the seriousness of the case, the Municipality may impose a temporary or permanent ban on entry and withdraw season tickets, without compensation and without prejudice to the penalties and sanctions provided for by any other legal or regulatory provision.
5. Groups of between 10 and a maximum of 30 people, plus accompanying adults, must announce their arrival by telephone the day before by 7.30pm. Groups are accepted from the time of opening until 3.30pm. Arrival times must be respected, as other groups may follow. Maximum time in the water is 1 hour.

Accompanying adults are required to respect the dress code, including the wearing of swimming costumes, on the pool beaches, whether they are swimming or not.

The "Pass Anniviers Liberté" (or other) must be presented.

6. The Municipality may:
 - Reserve part of the main pool for swimming lessons and other aquatic disciplines during certain hours ;
 - Temporarily prohibit the use of all or part of the pools without reduction or reimbursement of the entrance fee.
7. "1 entry" tickets and "10 entry" cards are not day passes. Users who leave the pool may be required to pay the entry fee again.

10-entry cards are valid for one year from the date of issue. After this period, unused tickets will be lost without refund.

Entries after 7.15 pm will no longer be accepted.
8. For safety reasons, pool staff have the right to open the doors of changing rooms and WCs at any time when a check appears necessary.

9. Persons suffering from open wounds, skin diseases or contagious diseases are not permitted in the bathing area.

It is also forbidden:

- To consume drinks or food in the changing rooms and in the pool area, or to smoke or chew gum ;
- Enter the pool under the influence of alcohol ;
- Throw paper, chewing gum or any other type of rubbish into anything other than the bins or other receptacles provided for this purpose.

10. You are required to:

- Change in the changing rooms and deposit clothes in the lockers ;
- To lather up in the showers only ;
- Shower before entering the pools ;
- Leave the pool at 7.30 pm at the latest ;
- Leave the facility by 8 pm at the latest.

11. It is forbidden to:

- Do somersaults and jumping to unauthorised depths ;
- Run around the pool, jostle or push people into the water ;
- Bathing in clothing other than swimwear ;
- Bringing in animals, pushchairs, rollerblades, skateboards or similar objects ;
- Use private electrical and electronic equipment.

12. Lost property must be handed in to the pool staff.

13. Children of any age must be always accompanied by an adult. We decline all responsibility in the event of an accident.

14. Pool users are personally responsible for any accidents they may cause.

The Municipality declines all responsibility in the event of accidents, damage, loss, theft or exchange of clothing or other objects, even if these have been locked in the lockers, changing rooms or changing rooms.

Cases in which the Municipality is liable by virtue of a legal provision remain reserved.

15. All complaints must be made in writing to the Anniviers Communal Administration.
